

PI NE COVE CAMP RULES 2025

Post in camper

1. Put lot number on camping unit, visibly facing the road for emergency access.
2. No additional camping units such as tents, children's tents, campers, motor homes etc. are allowed to be parked or used at your site.
3. Campsite, camping unit, boats, boat lifts, pier space, or any personal property may not be loaned or sublet to anyone.
4. Use of the site is limited to the camper's immediate family only. Overnight guests are allowed if an adult from your immediate family is with them. You may not have more guests than you have beds for and they may not sleep in vehicles, sheds or boats, etc.
5. Quiet time is 12:00 (midnight) till 8:00am in the campground. During quiet hours, activities like loud music, excessive noise, and rowdy behavior by campers and their guests are prohibited.
6. Minor children (under 21) may not use the trailer or site overnight without their parent being present. All children must be properly supervised throughout the day and must obey the 12:00pm quiet time and camp rules.
7. Only 2 dogs per site allowed. Prohibited breeds are: Pit Bulls, Dobermans, Rottweilers, German Shepherds, Great Danes, Akitas, Alaskan Malamutes, Siberian Huskies, and Wolf-hybrids. Pets must be confined to camper's campsite and kept quiet. Dogs shall be kept inside the CAMPING UNIT or on a leash. There are NO EXCEPTIONS to this RULE. Dogs may not be left unattended/alone anywhere outside. Dogs are only allowed on the beach in the morning until 10am provided there are no people on the beach or in the water. Pets will not be allowed to annoy other residents in any way. Guests are not encouraged to bring their pets.
8. Site must be kept neat, clean and orderly. Leaves must be raked and grass mowed by camper. Trees or brush on your site may be cut or trimmed but only with permission of the management.
9. Garbage (kitchen-type only) must be disposed of in the camp dumpsters provided. **DO NOT use the bar dumpsters!**
10. Use the septic system carefully!! Human waste, water and RV toilet paper are the only things that can go into the septic system. Do not flush wipes or feminine products of any kind. Clothes may not be laundered in your camper.
11. No washing of vehicles or boats is allowed. Watering of trees & flowers will be allowed between 2:00am and 4:00am on Monday thru Thursday ONLY.
12. Camper is responsible for proper installation and operation of all utilities on the camper's site.
13. Fire extinguishers must be readily available on each site. Handle and store all combustibles safely. All campfires and outdoor cooking must be done safely away from trailers, sheds, porches, trees, etc. and not in between trailers. Supervise all fires and do not leave them unattended.
14. No fireworks or firearms are permitted at Pine Cove.
15. ATV'S/UTV's and Golf Carts are the only off-road vehicles allowed to be operated on Pine Cove property and use must be in compliance with state and local laws. If you were born after Dec. 31, 1987 you must possess a valid safety certificate to operate an ATV/UTV in the state of Wisconsin. (www.dnr.wi.gov) No other off-road vehicles and powered children's ride-on toys are to be operated on these premises. To operate a GOLF CART you must have a valid driver's license or be accompanied by a licensed, responsible adult. Pine Cove assumes no liability for any of this activity.
16. Boat launch is available for free to use by campers. Campers are allowed to use the back of the event parking field to park their watercraft trailer while in use for the day. Boats may not be parked or stored on the beach, shoreline or bar piers. Storage of watercraft must be kept on your site unless approved by management with proper tags.
17. Due to very limited shoreline space, contact the management before purchasing or replacing any boat, lift or pier. All piers and lifts must be removed from the water at the end of the summer season.
18. Storage: All watercraft trailers must be stored in the designated empty field behind our home. Each trailer must be clearly labeled with its lot number for identification purposes. Other items: Off-site storage of any other items on Pine Cove property is strictly prohibited. Temporary storage: temporary storage arrangements may be possible with prior approval from management. Please contact management for inquiries or to request approval.

DUMPSTERS (on back road) ARE PROVIDED FOR:

Kitchen-type garbage ONLY

DO NOT USE BAR DUMPSTERS

ABSOLUTELY NO DISPOSAL OF

FURNITURE, GRILLS, CARPETING, ROOFING, MATTRESSES, APPLIANCES, BATTERIES, TIRES or any other LARGE items in the dumpsters! These items can be taken to Lenorud Disposal at 628 Hansen St Mauston M-F 8am to 4pm 608-847-2147 Or, they will pick up from your site.

NO DUMPING OF ANY KIND IN
ANY OTHER AREA.
